- The judges' decision is final and no correspondence will be entered into.
- Shortlisted finalists may be required to verify the information they have submitted if evidence provided is not sufficient. All information received and submitted will be treated in the strictest confidence.
- Finalists will be required to submit a photo when requested (to be used in the presentation at the event).
- The entrant must be either a member of the H&BNZ themselves or working/studying in a member salon or training provider to be eligible to enter. If you are not a member of H&BNZ and would like to enter the competitions, please visit the H&BNZ website to join.
- Should the entrant change salons after entering the competition their details will remain as the salon or training provider they entered under.
- The 2021 H&BNZ Competitions Committee members are not eligible to enter.
- Entrants must have been in the industry for under four years as at 31 October 2021.

## ENTRY REQUIREMENTS

---

### **Patrick wants to see:**

- Beautiful hair colours such as blues, greens, yellows, petrol pinks, reds etc, blended into the fashion forward fantasy styles.
- Technique of texture: braids/curls/waves/sleek/straight/diffused broken texture.
- Most importantly each look should reflect a special Aotearoa/Pacific Rim feel.
- Balance and harmony of total look eg. Fashion makeup choices creating a cohesive total look.
- Your eye for balance, originality, technical excellence and beauty.

### **Please note:**

- All entries must be signed by the entrant and appropriate waiver agreements completed.
- Photos must be taken on a mobile device. Professional photo shoots are not permitted.
- This year Patrick requires just 1 perfect shot to reflect your statement of Aotearoa.
- There must be no digital enhancement (including no computer enhancement) of photographs, however X-PRO II OPTION Instagram filter may be used.
- Hair pieces are allowed, and natural and synthetic hair extensions are allowed. Note: Any material that is a head piece or hair ornament worn on the head is allowed providing it does not restrict the viewing of the hair and face, and/or is constructed out of natural or synthetic hair.
- Minimum 30% of model's own hair to be visible.
- Male, female, transgender, gender fluid models allowed.

**NOTE:** Please make sure your Instagram Account is **not on the private setting** (otherwise we will not be able to see your image).

## TERMS & CONDITIONS OF ENTRY

---

### 1. Originality

The Entrant must be the original creator of the hairwork represented in the photography. **All entries must be original and previously unpublished**, this includes all online media formats and behind the scenes photos. You cannot submit "out takes" or another edit of the same shoot, however, you can use the same model, restyling the hair and clothing in a different manner, for submission. Photographs submitted for competition cannot be used to enter other photographic competitions or posted on any website or social media except for the purpose of this competition by the Entrant until the winners have been announced on the 7th of November 2021.

### 2. Copyright

Copyright of the submitted entry or entries remains with the photographer and barber. Approval for entry and use of that entry or entries in the competition is the responsibility of the Entrant who must have the written permission, or alternatively a licence, from the barber and photographer for such entry or entries or use, including the use by The Industry Awards and H&BNZ for any legitimate purpose and in any fora.

### 3. Reproduction Rights

The Industry Awards and H&BNZ may reproduce an entry or entries in any existing or future medium of its choice for a period of five years from the closing date of entries. The Industry Awards and H&BNZ undertakes not to trade that entry or entries for any gain or for any other use to any party, apart for promotional purposes, without first obtaining the written permission of the copyright holder(s).

### 4. Moral Rights Protection

The Industry Awards and H&BNZ acknowledge the moral rights provisions of the Copyright Act 1994 including the right of the barber to be identified as the author of any entry or entries.
